She holds a Masters of Visual Arts from the University of Sydney and has exhibited regularly across Australia in institutions and artist and community-run art spaces. Board member since 2011.

### Penny Coss – artist (from May 2011)

Penny is predominantly a painter. Over 20 years, her practice has included developing local, national and international opportunities; representations in collaborations and individual forms; exhibiting in public and commercial galleries; lecturing and teaching; working in community and public art projects; and Artist Run Initiatives. Board member since 2011.

### Fleur Schell – artist (until May 2011)

Fleur is well known as an accomplished ceramic artist with an international profile. She lives and works in North Fremantle where she has established the SODA International Ceramic Residency and Studios. Fleur trained at Curtin University in WA and achieved First Class Honours in ceramics at the Hobart School of Art in Tasmania. Fleur brings her passion and energy for developing and connecting artists. Board member since 2009.

# Chairman's Report



Looking forward we have a number of important projects on the drawing board ... Western Australia is going through a dynamic period in its history.

Throughout 2011 Artsource continued to demonstrate that it is a successful and thriving organisation with a team of professionals who are working effectively on behalf of members to develop the visual arts in Western Australia.

As we celebrated our 25th year, we recorded a number of achievements that are worth highlighting because they will help Artsource support its members for another quarter of a century.

At the start of the year the Board finalised a new threeyear strategic plan for Artsource that will increase our ability to service and promote member's needs. In particular, we will focus on expanding our studio and consultancy activities; improving advocacy on behalf of visual artists at all levels of Government; and increasing our financial strength and independence by ensuring we have multiple revenue streams.

Our public arts consultancy continued to grow in size and complexity and filtered more than \$15m in opportunities for visual artists. Our studio spaces are set to expand by 30% in early 2012 with the opening of The Ward in Leederville.

A significant moment during the year was the successful completion of major artworks for a commercial development in Abu Dhabi as well as the selection and delivery of 2,482 works for another part of this project. While this contract has provided new challenges, it has also delivered many rewards including establishing a foothold for Western Australian artists in the Middle East and creating new expertise and income for Artsource. It was pleasing to see that as a result of all these activities our proportion of Government funding fell below 20% during the year. This increases the strength of our organisation for the long-term by ensuring we are not reliant on any single source of funding and is testament to the excellent financial management of the Artsource team.

One of the important, but under-rated successes of Artsource, is the continuing smooth transition of Board members. The interest and expertise of a strong volunteer Board is vital to our organisation and this year we saw artist members Penny Coss and Olga Cironis join Geoff Drake-Brockman on the Board. Long-time Board member Bob Poolman will step down in 2012 after spending an invaluable eight years assisting Artsource to develop into a thriving organisation.

Looking forward we have a number of important projects on the drawing board, including developing plans for the ground floor of Old Customs House Fremantle, seeking a longer-term lease over this building from the Department of Culture and Arts, identifying opportunities to provide more studios and increasing our focus on fundraising opportunities.

Western Australia is going through a dynamic period in its history. There are many changes occurring in our communities at the moment and it is vital that Artsource ensures that the visual arts obtain a long-term benefit from this exciting period of economic and social growth.

# Executive Director's Report

The year of our twenty fifth anniversary of continuous operation supporting and advocating for Western Australian artists was one of distinct highs and lows.

High points included a birthday party, our annual lifetime achievement awards and the privilege of seeing exceptional works of art created by members. Low points were looking on while another year of poor sales and slow moving commissions, flattened the spirit.

In a year where we would be looking back over 25 years, we also wanted to look forward; to consider the future of arts and culture in WA and to think about what artists will need from their membership body in a strange new world ten and twenty years on.

The process re-focussed the need for long term, sustainable access for members to spaces to conduct their practice. Consultation with twelve other artist member groups and artist run initiatives helped to consolidate our thinking. This lead us to prioritise the need for more and better buildings in our 2012/14 business plan and to review our current building uses.

Part of that included a review of Artsource Fremantle and inconsistencies in our approaches to sub tenants. In order to be fair to our long term tenants – in particular the WA Circus School and Nova – we gave those groups extended notice that a result of the review would likely see Artsource resuming the spaces the groups had occupied for twenty years.

We involved our membership and key stakeholders to consider the un-met current needs of members, changing artforms, and the cultural and social landscape. The work on the ground floor in Fremantle continues and with thanks to the thoughtful input from our membership, we now have a clear way forward.

2011 is also memorable for the number and range of policy development and reviews that took place at state and federal levels, that will have a significant impact on WA artists.

Nationally we contributed to the federal government call for submissions to the development of a National Cultural Policy, the Mitchell review into philanthropy, reform of the Not For Profit regulator, and the Australian Law Reform Commission National Classification Review.



The Department of Culture and the Arts continued work on the arts and culture policy framework as well as a Venues Policy and a Cultural Infrastructure Directions Policy. All of these pieces of work required input at varying times during the year.

Working through the Chamber of Arts and Culture WA and the Cultural Executives Group, we contributed to an inaugural survey into the health of the sector and development of a pre budget submission to the State Government. We are seeing our sector work collaboratively through these mechanisms and I see this stronger approach as leading to greater rewards for our members individually in the long term.

### Where to from here

We will be working vigorously on issues around long term housing for artists and developing our Patrons Program that underpins the *Go Anywhere Residencies*. The state, national and international advocacy work that promotes the capacity and strengths of Western Australian artists will continue. We will continue to lobby for a greater share of federal funding for WA artists and increases in support from the state government.

# Membership Services

Fundamental to Artsource's role is assisting our members to earn greater income and recognition from their art practices.

We do this through our professional development program, a suite of varying levels of membership that address individual requirements, regular electronic communications, a thrice yearly newsletter, general advice and linkages to additional support systems.

### **Professional Development and Networking Program**

Our professional development and networking program is a core element of our services to members and in 2011 we ran 19 PD sessions attracting 527 attendees.

This included six networking sessions each featuring 6 artists talking for 6 minutes about their practice or a specific project. These sessions not only share knowledge, they are excellent opportunities for members to strengthen their public speaking skills. 39 artists presented at these sessions in 2011.

We partner with other organisations in the delivery and hosting of these sessions including governments, private businesses and arts organisations to broaden the potential networks for our members.

A new position of Manager, Membership Services was established at the commencement of 2011. Having the focus of this new position allowed several initiatives to be trialled this year. One of these was the clustering of events so that members could attend two or more short sessions on one occasion. For example, the workshop on writing better public art expressions of interest was followed by a 6x6 event that featured artists working on public art projects. Attendance at these thematically paired events was higher than that at our stand alone events.

### **Communications with members**

A weekly +Mail for our PLUS and MAX members filters employment and commission opportunities and includes jobs that require a visual arts knowledge.

Our fortnightly ezine for the whole membership promotes workshops, broad professional development, studio and residency vacancies, funding opportunities, awards and promotes members exhibitions.

Our thrice-yearly newsletter features hot topic issues, profiles of artists, members news and an update of our programs.

Facebook continues to develop a following, alerting members to news and events.

### Membership

The composition of Artsource's membership is changing. The number of MAX members grew in 2011 whilst the number of Access and PLUS members declined.

The previously badged *Client Membership* category was reviewed and modified to become *Associate Membership*. This enabled us to better manage our relationships with other arts organisations, artist groups and the partnerships developed with non-artists through all programs. At the close of 2011, there were 96 Associate Members.

### Where to next?

In 2012 we will extend our PD program into regional centres. This self-funded but vital strategy signals Artsource's will for a meaningful engagement with our regional membership.

The 6 x 6 sessions are highly regarded by members and will continue.

# Studios

Having a studio helped my practice grow and helped me feel like a real artist. I may have gone back to work as an engineer if I didn't have a space – (it's) easy to be disheartened on your own!

The Artsource Studios program acknowledges that suitable working spaces for artists are fundamental to artistic practice and the development of a professional career.

The program aims to offer a tangible service to artist members in the provision of these spaces, by seeking out appropriate buildings and working with building owners to manage the head leases on behalf of the artists. With Artsource taking care of the administration and ensuring that studio rents are more affordable than regular commercial arrangements, artists are left to do what they do best! Where possible, Artsource offers five-year tenure to studio tenants, allowing stability for a continuous period.

In 2011, Artsource managed 61 studios in the Perth metropolitan area in 7 buildings:

**Fremantle** – an important milestone in our studio delivery was reached in 2011, with the 25 year anniversary of the Artsource Fremantle studios in Phillimore Street. This was timely recognition that the building had housed over 180 artists since its inception. Applying for a Fremantle studio remained a competitive process, with twenty applications received for ten available spaces in 2011.

Midland – the Artsource Midland building housed 18 artists with steady tenure throughout 2011. Two years into a five-year lease, the building has proven to be a vital space for artists living in the eastern suburbs of Perth. A combination of established and emerging practitioners has contributed to a strong sense of collective in the building.

**Belmont** – three artists continued to work from small studio spaces in Garvey Park. Through a partnership with the City of Belmont, a former kiosk perched in the centre of a park provides a picturesque studio overlooking the Swan River and surrounded by stunning bushland.

**Haig Park** – four artists worked in studios at this residential complex managed by Foundation Housing.

Two artists are also offered an apartment in the complex, along with a studio space. These small spaces are ideal for concept development and design work.

**Settlers Cottage** – four artists are working from this heritage landmark in Churchlands. The site has now been earmarked for a children's respite centre, and Artsource will terminate the lease with the National Trust in 2012.

**Kelmscott** – a house and two sheds make up this impressive site. Artsource manages the complex through a partnership with the Armadale Redevelopment Authority, on land reserved for future road-works.

**Amherst Street** – one semi-industrial space is leased to an artist in the heart of the White Gum Valley precinct and has provided a secure studio for three years.

### Advocacy and development

We continued to cast our eyes around for new studio spaces – particularly close to the Perth CBD as this has been a consistent request from members. By the end of the year, a building in Leederville presented an opportunity to negotiate for studio spaces on the site. The Artsource 'Ward' studios were up and running by February 2012.

By mid-year, Artsource had started to consider the future usage of the Fremantle building, consolidating the organisation's commitment to visual artists. Artsource needs to both meet the requirements of newer forms of practice and continue to provide appropriate space for existing forms. We have the opportunity to explore the many needs of visual artists and to identify the most beneficial way to redevelop spaces for the next 25 years.

### Where to next?

We will continue to actively search for appropriate buildings that meet the varied requirements of our members and with a specific focus on long term leases to enable our members secure spaces.

# Residencies

The Artsource Residency program recognises that travelling for research and development can be an important element in maintaining a successful artistic career.

The program offers funded residencies to enable artists to 'take on the world', and also provides accommodation for visiting artists to share their insights with Western Australian artists.

The generosity of Artsource Patrons has enabled the Artsource *Go Anywhere* residency program to grow. In 2011, three artists travelled to Berlin, Kent (UK) and New York; and from donations received of \$27,750 a further two grants were approved to support three artists to travel to New York in 2012.

Artsource manages a studio apartment in the Fremantle studios building to provide a living and working space for artists visiting Western Australia. From February to July each year, the space hosts the Swiss exchange artist, and for the other six months of the year it accommodates regional, national or international artists that apply to use the space.

The program looks at ways of developing partnerships with other arts organisations in order to benefit Artsource members through networking opportunities or through the exchange of information in regards to art practice around the world. In 2011, Artsource hosted an artist through the AsiaLink Taiwan residency in conjunction with PICA, as well as establishing an inaugural residency with Sculpture Square in Singapore.

### **Basel and Artspace**

In 2011, Artsource continued to administer the two long-running and successful residencies funded by the Department of Culture and the Arts – to Basel, Switzerland and Artspace in Sydney. This long term support ensures that Western Australian artists have assured opportunities to apply for those residencies.

**Kate McMillan** received the Basel residency, allowing for an uninterrupted six months for her to focus solely on art making.

This was the first time I have had the benefit of a large studio space. It was also one of the few times that I have had a block of focused time solely on art making. Perhaps due to this I felt an overwhelming desire to move away from the large-scale, outsourced projects that I have more recently been working on and go back to the handmade. I found the pressure not to 'produce' or work towards project deadlines was extraordinarily liberating. Perhaps for the first time since I was an undergraduate student, I was able to explore, experiment and play for long periods of time. Elise Harmsen and Jurgen Kerkovious (Elise/Jurgen) received the Artspace residency, a three-month opportunity to make and present work in the heart of Sydney.

### Go Anywhere Residencies – supported by Artsource Patrons

Holly Story – undertook an eight week residency at King's Wood in Kent, UK, supported by Stour Valley Arts. She used the opportunity to engage as an artist with this historic site in the south east England, investigating notions of landscape and place through personal and historic references to English botany and natural history.

**Elizabeth Delfs** – undertook a six-month residency in Berlin, Germany, to help build professional networks in the region.

Adam Derums – travelled to New York, USA, to develop new work and explore exhibiting opportunities.

In many ways what I actually gained from the residency exceeded what I hoped to achieve on a number of levels, some of which were unplanned. The ability to be able to work on my practice all day, every day of the week, is something I haven't been able to do for many years. This enabled me to complete in two months what would normally take over a year to achieve in my normal routine.

# Regional + Indigenous Development

The Regional & Indigenous Development Program works with visual artists across regional Western Australia, who otherwise wouldn't be able to draw upon the support and information more easily accessed in metropolitan WA.

This program was primarily developed with Indigenous artists in mind, but has always offered its services to any regional visual artist in need of support or advice.

Above all things, Artsource actively encourages community grown initiatives that allows for a 'grass-roots' approach, enabling visual artists to identify their own needs and develop their own solutions. Artsource fully understands the need for activities and projects to belong to the people who wish to grow and invest in them and for these initiatives to remain in the community that builds them.

We work with artists across the Pilbara, Gascoyne, Mid West, Goldfields, South West and the Greater Southern regions of WA. We also develop and support projects that directly involve artists in these regions, as well as the Kimberley. We work with key resource industry partners such as Rio Tinto and BHP; we develop meaningful relationships with Local Government Bodies such as the Greater City of Geraldton and Greenough; we grow our relationships with artist representative bodies in these areas; we remain connected with local galleries and arts initiatives wherever possible and we constantly aim to foster our relationship with the most important people we're aiming to support: the visual artists themselves.



sphere of public art opportunities for Indigenous artists. In late 2010, Artsource ran an 'Introduction to Public Art' workshop and we have seen early and remarkable results in 2011. Artists Wendy Hayden and Deborah Bonar partnered with Joanna Robertson to produce the Munday Wall: a commission on behalf of the Cooling Bros Glass Company, looking to revitalise the front of their industrial workshop in High Wycombe. It was their hope to capture a unique local story in the area – that of the Munday Swamp – and in doing so showcase their new technique applicable to glass on a large scale.



We also entered into a new sponsorship partnership with BHP to work in and around the Goldfields town of Leonora. At the end of her *spaced: art out of place* residency through IASKA, artist Kate McMillan in discussions with local identity Kado Muir and The Shire of Leonora approached Artsource with a view to further artist development in the area. BHP provided a small exploratory grant for Artsource to continue Kate's work and to gauge the level of interest and skill in the area. Workshops were programmed with Nalda Searles and Magabala Books to introduce new opportunities to the Leonora artists; these workshops quickly identified a town community keen to reinvigorate visual arts practices in the area. Artsource will now work with BHP towards securing a longer term, artist development program in Leonora, in league with key stake holders in the area.

In partnership with Rio Tinto, Artsource continued to work with art centres in the Pilbara. Local administrative and community issues demanded considerable time of the artists in Roebourne in 2011. In spite of the challenges, Roebourne's artists continued to pepper away and produce amazing artworks, winning three categories in the Cossack Art Awards and enjoying success in Rio Tinto's *Colours of Our Country* exhibition. This exhibition became a major highlight of their year as over 200 artworks from 44 Pilbara based artists were exhibited, with more than 150 of the artworks selling.





Artsource has also had the pleasure of continuing to support and mentor Colette McEntee and her growing team at Archipelago Arts in Karratha through both the R&I program and the Consultancy Team. Archipelago Arts are managing a wide range of art projects that develop local artists and businesses, all of which Colette has managed to grow herself. The demand for Archipelago Arts and the opportunities this offers local artists has been staggering and Artsource is excited about the prospects this brings to both Archipelago Arts and the artists from the surrounding communities and towns. These projects include public artworks for the expansion and redevelopment of the Dampier Highway; development of public artworks around the town of Wickham; ongoing projects for the Shire of Roebourne (including the Cossack Art Award) and ongoing community projects as they arise.

In 2009 Artsource engaged artist Jánis Nedéla from Gallery East to take part in regional studio visits. In Geraldton four artists opted to take part in ongoing one-on-one practice development. These four artists have grown remarkably and this support has contributed to the following successes in 2011:

- Three artists were accepted into the Mid West
   Art Awards
- One artist participated in the Oakagee Port & Rail
   Good heART exhibition

- Three artists were invited into a group show at Gallery East
- One artist exhibited in Geraldton
- Two artists participated in the 2011 Cossack Art Award

### Advocacy

The advocacy work of the Regional & Indigenous Development program continues to grow. It is encouraging that the demand for Indigenous artists to run workshops or speak on local topics is increasing. Additionally, more organisations, Indigenous and non-Indigenous artists and businesses regularly seek advice and support when aiming to work within an Indigenous context or work with Indigenous content, in the development of artworks, activities or projects. Some of the highlights in 2011 were:

- 5 Indigenous artists held Artsource studios through 2011
- Tania Ferrier and her exhibition *The Quod Project* at the Geraldton Regional Art Gallery
- Representing Artsource at the National Gallery of Australia – assisting in the delivery of the Wesfarmers Indigenous Arts Leadership Program
- Presenting Keeping Places from an Arts and Community Point of View at the Perth "Museum's Australia" National Conference

- Assisting Magabala Books to develop support for sustainable ongoing Indigenous Illustration workshops across WA
- Ongoing development of the Nyoongar Art Award for the City of Rockingham and the Town of Kwinana
- Ongoing support to the Artist Hub of WA
- Providing professional development sessions about the Indigenous art of the Pilbara to anthropology interns through Context Anthropology

- Ongoing support to Nan Rickards in the presentation of the following Indigenous group exhibitions:
  - Rio Tinto Colours of Our Country
  - Woodside We Are From This Country
  - Oakagee Port and Rail Good heART

### Where to next?

Indigenous artists struggle to take part in the wider opportunities that exist and often aren't well placed to take advantage of these opportunities as they arise. As with all visual artists, one of their fundamental needs is long-term studio space and our aim for 2012 is to develop more support for Indigenous artists to take up residency in our Artsource studios. One of the biggest challenges facing our Indigenous artists is maintaining these spaces for a long period of time. We seek to develop sponsorship for Indigenous artists that will allow potential patrons to support individual artist's studio rent for 1 to 5 years studio tenure.



# Consultancy & Employment Services

### In 2011, 77 artists earned \$2,192,538 through Artsource Consultancy service

Artsource consultancy aims to secure employment and economic outcomes for our artists and advocate for better processes, diversity and excellence in the visual arts.

We work to connect artists with the business sector for projects that have artistic integrity and suitable remuneration.

Artsource Consultancy works in metropolitan and regional Western Australia as well as internationally in the Middle East. We develop strategies and policies in relation to public art, provide a curatorial service, coordinate projects and provide an art leasing service.

We secure employment opportunities for artists through matching the requirements of clients to the skills and capacities of our artist members. These range from promoting artists for artist-in-residence at schools; recommending artists to architects looking to commission art work; to supplying names of artists who can run workshops into environmental art practices. *In 2011, Artsource filtered 254 employment opportunities valued at \$15,728,000* 

We work with the business sector to establish strategies and processes that are fair to artists and help set the ground-work for an exciting and rich public realm. We prepared and presented in excess of 45 proposals containing thousands of images of members work. This wide advocacy enables a large number of potential and existing clients to understand the breadth and depth of WA artists practice. We also gave three public talks reaching audiences of around 150 design professionals, arts organisations and other people with an interest in the visual arts.

As curator of a pilot project to install temporary and ephemeral works for the Perth Cultural Centre, Artsource commissioned 12 temporary installations on behalf of East Perth Redevelopment Authority (now Metropolitan Redevelopment Authority). This allowed us to host projects jointly with PCC stakeholders such as PICA, AGWA, State Library, State Records Office and the WA Museum.

Mentoring regional, Indigenous and emerging artists also forms an important part of our work with projects such as the *Munday Wall* enabling us to deliver greater diversity in public art.

Regionally, Artsource worked with:

- The Shire of Roebourne and Karratha based project partners Archipelago Arts in managing the Cossack Art Awards;
- Landcorp and UDLA on the development and installation of artworks in a public park in Newman;

- The Town of Bridgetown on the approach for a public art;
- Waringarri Aboriginal Arts in Kununurra to develop public art for a LandCorp project;
- The Town of Kwinana to commission artwork which was integrated into the building of the new Community Knowledge and Resource Centre;
- The Shire of Derby on the valuation of their art collection; and
- The City of Mandurah to assist them to establish new gallery and studio space.

### International Consultancy

Artsource's work developing international markets for Western Australian artists is under-pinned by the need to expand artist members' profiles and incomes beyond state boundaries. The artConnect project has generated real employment opportunities for WA artists in Singapore and the Middle East.

An additional component of that work has been an expansion of our consultancy services as we locate emerging markets with a requirement for curatorial and procurement skills. These longer-term projects associated with infrastructure developments have also created new connections to artists, galleries and associations much further afield. We believe that there are enduring benefits for our members within this wider focus.

In 2011, we made presentations to 15 potential and existing client groups in the Middle East.

12 artists shared \$369,543 in payments for purchases of work destined for a project in Abu Dhabi

### ArtLease

ArtLease is a service where we lease members work to clients. The lease fee provides an additional income stream to artists who work mainly in two dimensions and gets their work into some large corporate collections. The work remains for sale whilst it is leased.

### Advocacy

Artsource consistently advocates within the visual arts sector. We offered advice to local government in regions as diverse as Mosman Park, Albany and Derby. Individual artist members receive advice about public art contracts and commissions, art teachers about artist in residence and performing artists and sound specialists about visual arts curators.

We took part in industry reference groups with Central Institute of Technology and Future Now for arts related training and participated in professional development with architects, landscape architects and heritage planners. Artsource either consulted or advocated in every geographical region within Western Australia.

In 2011, Artsource worked with a number of property developers to develop public art strategies and deliver public artworks. We partnered the Urban Development Institute of Australia (WA) with support from the Department of Culture and the Arts to undertake a survey with property developers to establish views on public art, including what barriers they perceived as being present to the provision of public art within their developments.

We partnered with Artsedge and the Graphic Design Association in presenting professional development to teachers and with a private developer in presenting public art professional development to emerging artists. We strengthened our ties with other visual arts professionals such as galleries, valuers and art consultants through our consultancy work.

### Where to next?

Our business plan for 2012 targets the promotion of excellence, innovation and diversity in public art commissions and the refinement of these commissioning models. We will continue to advocate for improving practices amongst clients that support artists and the vibrancy of visual arts within WA. We will strengthen our networking with design and industry professionals, giving us more opportunities to promote the work of our artist members to potential clients and collaborators.



### Finances

As a not-for-profit organisation our objective is not to make profit, but rather to ensure the income we earn supports artists effectively and that our operations are sustainable. Income is generated from a number of avenues and in 2011 all but \$663 was expended on activities in the support of artists.



Our core funding grant from the Department of Culture & the Arts increases moderately each year through CPI indexation. However, our total turnover continues to increase significantly from the growth in core activities such as additional studios, consultancy projects and membership fees. The effect is that the DCA grant represents a smaller percentage of the organisations total income although the actual amount has not reduced. Whilst it is a major achievement that our growth is funded through our own resources, it does not reduce the significance of receiving this core administration grant each year.

Turnover increased to \$1.8m (up from \$1.3m in 2010) and was due to the following:

- Continued growth in Consultancy Services activity generated an additional \$110k in income from 2010
- The two Abu Dhabi Consultancy projects increased both Consultancy Project Income and payments to artists

 The focus on sponsorship generated additional income

It is significant that the increase in turnover has had the flow-on effect of increasing payments to artists by over 200% to \$626,865 in 2011; up from \$208,190 in 2010.

The increase in donations is pleasing; to date, these funds have all been committed to artist residency grants. Donations are shown as a separate amount within our overall equity position. This is to reflect our commitment that donations are clearly quarantined until they are allocated as artist grants.

### Where to next?

Although the equity position is adequate to cover the minimal risk factors of our day-to-day business, our plan is to gradually increase the equity over the coming years. This will give us additional security and options as we continue to grow and develop new markets.


