# **Board of Directors**

Fred Chaney, Chair, is an architect and Director of Taylor Robinson Chaney Broderick. The work of the practice is guided by Fred's abiding interest in achieving excellent public and community outcomes,



and the creative processes that underpin those objectives. Fred has delivered award-winning projects in the university sector, training and secondary education, justice, planning and urban design. Fred has taught regularly at architecture schools in Australia including the University of Western Australia, Melbourne University and RMIT University. He is the Chairman-of the Australian Urban Design Research Centre in Perth. Fred has been a Board member since 2016.

Simon Gilby, Deputy Chair, is an accomplished contemporary artist who graduated in 1990 and has since been making art primarily as sculpture for public exhibition and permanent public



artworks. He has lectured and taught at local universities, TAFE, secondary and primary schools and has worked as 'artist in residence' at several aboriginal communities.

Simon is experienced working with community groups, artists with disabilities and has organised and curated art events and exhibitions. He is the founding Artist of the ongoing Syndicate Project. Simon was a Board member from 2018 to 2020.

Penny Bovell is a leading WA artist and has been a member of Artsource for many years. Penny brings experience of board governance gained from 30 years of participation in arts organisations, including being a founding member of the Mark



Howlett Foundation (1991 to 2011), Artemis (1985 to 1987) and, more recently, the Art Collective WA, founded in 2013. With many years experience as an academic at the University of Western Australia and Curtin University and a diverse practice involving exhibitions, public art and curatorial projects, Penny brings a broad range of knowledge of visual art and the ability to assist with future strategic planning. Penny was a Board member from 2016 to 2020.

Mal Di Guilio, is Managing Director at Nexia Perth, a financial advisory firm that provides a wide range of financial and business advice. The company was established in 1976 and employs 100 people. Mal's

employs 100 people. Mal's involvement with Artsource commenced when he became a Patron in 2009; he has extensive financial experience and has keen involvement with the artist community. Mal is an Artsource Patron and was a Board member from 2012 to 2020.

## **Rick Vermey** is

an accomplished contemporary artist, who has been closely engaged with Artsource from its beginnings, including as a previous Board member. Rick has a wide-ranging



visual art practice that incorporates print, photography, painting, sculpture and public artworks. He has a substantial exhibition history and maintains an ongoing studio practice. His artworks have been widely collected by Western Australian public collections and his public art projects have been recognised internationally with industry and architectural awards. Rick has been a Board member since 2016.

Jon Denaro is a sculptor and founding director of ObscureView. He brings to the Artsource board 30 years of experience seated in making, teaching and in working across cultural projects. Jon has an



understanding of the regional context for arts practice in WA. He has served on selection committees for the Dept Education and DCA and is currently Chairman of the Perth Arts Precinct Town team. Jon was a Board member from 2019 to 2020.

Leanne Bray has worked as a full time arts professional for over 35 years. As a self-confessed risk taker - she has maintained a busy and varied inter-disciplinarian and professional



background, which enables her to tackle just about any creative design project that requires hands on skills. Leanne has used the combination of strong technical background and sound conceptual development and combined it with the management skills that she has developed over the last fifteen odd years through her own businesses. Leanne was a Board Member from 2018 to 2020.

### Vincent Allegre,

Vincent is a corporate executive in the energy industry having lived and worked on all the continents. He is today the Country Manager of a global Malaysian



engineering and construction company representing the group in Australia, New Zealand and Papua New Guinea. He was born in France, he migrated to Perth in 2003. Vincent became Australian in 2017. His journey has provided him with a formidable experience in leadership and governance including overseeing implementation of agreed strategic initiatives. Vincent has been a Board member since 2018.

## Julie Hobbs

Julie is the Chief Executive Officer of FutureNow, Creative and Leisure Industries Training Council, a not for profit organisation that produces research and advice about current



and projected workforce needs. Julie has a background as a creative practitioner, educator and business person. Her multifaceted career has encompassed the private and public spheres as well as engagement with the not for profit sector. She has held leadership positions within the Design Institute of Australia, the multidisciplinary peak body for Australian design, serving as WA President from 2009 to 2013 and more recently as National President from 2014 to 2017. Julie was a Board member from 2018 to 2020.



# Chair's Report

Artsource began 2019 with an invigorated board and significant challenges ahead of the organisation to reassert its relevance and reputation with both its membership and stakeholders, including the state government, our long-time partner and supporter.

Recently appointed board members Simon Gilby, Leanne Bray, Julie Hobbs and Vincent Allegre each contributed both energy and expertise to renewing our vision and strengthening our governance and financial management processes. Chair, Penny Bovell, stepped down mid-year, after making an enormous contribution as both Chair and temporary Executive Director, during a period of some tumult and difficulty for Artsource. Penny's personal commitment cannot be overstated, and Artsource and its membership is indebted to Penny for her energetic leadership of the organisation over the past few years.

In 2019, Artsource set itself the task of managing its limited finances, maintaining core services to members, strengthening its governance and management processes and charting a course for a reinvigorated and re-funded organisation.

As General Manager, Sue-Lyn Aldrian-Moyle has managed a small team that has demonstrated exceptional commitment to Artsource's membership and the maintenance of our studio services, professional development programmes and networking events. Highlights of 2019 included the Galvanise exhibition at Old Customs House, our partnership with the Fremantle Biennale and the Now exhibition that hosted the work of 140 Artsource artists.

Despite the hard work of the board and the Artsource team in refashioning the vision for the future Artsource, our major OIP funding bid was only partially recognised and supported by the DLGSC. In October 2019, the board was advised that the government would provide Artsource with a \$100,000 operational grant, only, and that further and significant work would be required to demonstrate the relevance and capacity of the organisation.

This disappointing outcome is at odds with Artsource's ongoing role as a major arts industry representative and a membership body with over seven hundred active and engaged members and supporters. In discussions with department representatives, the board determined that it would commit to a further, major review of its operational model and that it would take this proposal to an Extraordinary General Meeting (EGM) held in December 2019.

At the EGM, the board presented the membership with three scenarios: continuation and restructure; a merger; or wind-down.

Over 160 members present voted in favour of maintaining the organisation. Two members voted for a wind-down.

At the time of writing, we are being presented with unheard-of challenges associated with the COVID pandemic, but our organisation is already demonstrating its central role and capacity to support our artistic communities and their endeavours.

So Artsource began 2020 with refreshed support from our membership, some significant challenges ahead of us and the ongoing commitment of our dedicated and passionate Artsource team. At the time of writing, we are being presented with unheard-of challenges associated with the COVID pandemic, but our organisation is already demonstrating its central role and capacity to support our artistic communities and their endeavours.

I would again like to thank our outgoing board members Rick Vermey, Leanne Bray and Penny Bovell for their support of the Artsource organisation. I would also like to acknowledge our membership and all artists and art practitioners for their indefatigable enthusiasm and passion for the rich universe of the visual arts and its critical role in maintaining a healthy and enriched community and society.

# **Auditor's Report**

#### Opinion

We have audited the financial report of The Artists Foundation of Western Australia Limited ("the Company"), which comprises the statement of financial position as at 31 December 2019, the statement of profit or loss and other comprehensive income, the statement of changes in equity and the statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, and the board members' declaration.

In our opinion: the accompanying financial report of the Company is in accordance with the Corporations Act 2001 and the Australian Charities and Not-for-profits Commission Act 2012, including:

- (i) giving a true and fair view of the Company's financial position as at 31 December 2019 and of its financial performance for the year then ended; and
- (ii) complying with Australian Accounting Standards and the Corporations Regulations 2001 and Australian Charities and Not-for-profits Commission Regulation 2013.

#### **Basis for Opinion**

We conducted our audit in accordance with Australian Auditing Standards. Those standards require that we comply with relevant ethical requirements relating to audit engagements and plan and perform the audit to obtain reasonable assurance about whether the financial report is free from material misstatement. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Report section of our report. We are independent of the Company in accordance with the auditor independence requirements of the Accounting Professional and Ethical Standards Board's APES 110 Code of Ethics for Professional Accountants (the Code) that are relevant to our audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

# Other Information

The board members are responsible for the other information. The other information comprises the information included in the Company's annual report for the year ended 31 December 2019, but does not include the financial report and our auditor's report thereon.

Our opinion on the financial report does not cover the other information and accordingly we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial report, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial report or our knowledge obtained in the audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

## Responsibilities of the Board members for the Financial Report

The board members of the Company are responsible for the preparation of the financial report that gives a true and fair view in accordance with Australian Accounting Standards, the Corporations Act 2001, the Australian Charities and Not-for-profits Commission Act 2012 and for such internal control as the board members determine is necessary to enable the

preparation of the financial report that gives a true and fair view and is free from material misstatement, whether due to fraud or error.

In preparing the financial report, the board members are responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the board members either intend to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

### Auditor's Responsibilities for the Audit of the Financial Report

Our responsibility is to express an opinion on the financial report based on our audit. Our objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the Australian Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this financial report.

As part of an audit in accordance with the Australian Auditing Standards, we exercise professional judgement and maintain professional scepticism throughout the audit. We also:

If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial report or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Company to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial report, including the disclosures, and whether the financial report represents the underlying transactions and events in a manner that achieves fair presentation.
- Obtain sufficient appropriate audit evidence regarding the financial information of the entities or business activities within the Company to express an opinion on the financial report. We are responsible for the direction, supervision and performance of the Company audit. We remain solely responsible for our audit opinion.

We communicate with the board members regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide the board members with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.


