Please note:

- Unsold artwork is to be collected from the Atrium. There will be no Northern Suburbs collection.
- > The invigilation of the exhibition will be done by members and a roster is available online (you can also call us!) We do encourage you to find a little time to participate and thank you in advance for your involvement! It's a great opportunity to really explore the exhibition yourself and share your knowledge with the visiting public.
- > All sales will be done by Artsource staff, you will not be required to handle funds.
- > To assist with catering for the Sundowner, those who are able are encouraged to 'bring a plate' to share. Please label as appropriate to assist those with dietary requirements, ie: 'dairy-free', 'nut-free', 'egg-free'.



CONDITIONS OF ENTRY

The exhibition is managed by Artsource and the Old Customs House Atrium Advisory Panel. Entry is open to Artsource members only.

ARTWORK, ACCEPTANCE & EXHIBITION

- 1. Artwork must be the original work and concept of the artist.
- 2. Each entrant may submit ONE work only.
- 3. Submitted work must be for sale.
- 4. The work will be hung salon style at Old Customs House, 8 Phillimore Street, Fremantle WA 6160.
- 5. Entry form must be received by 5pm (AWST) 16 November 2018.
- 6. Works must be delivered during the specified times:
 - a. Sunday 2 + Monday 3 December, 12pm to 4pm or by prior arrangement.
 - b. There is a drop off point for Northern Suburbs members at Leanne Bray's: 16 Glenwood Avenue Helena Valley on Saturday 1 December, 10am to 4pm.
- 7. Works must be delivered suitably presented and ready for display/hanging. Flat D-rings must be placed at the back of the work, approx. 10cm from the top of the frame. Cord or wire must also be included for hanging. (Wet paintings will not be accepted.)
 - a. 2D work must not exceed 1m x 1m in any direction including frame. Any work over these dimensions, will not be accepted.
 - b. 3D work entered into the sculpture category must not exceed 1m x 1m in width and depth and 3m in height.
- 8. Artists submitting 3D work must provide their own plinths/ supports
- 9. The weight of the entry should not exceed 15kg for 2D works and 30kg for 3D works.
- 10. Artsource will not accept responsibility for the visual representation/ interpretation of any works. It is the artist's responsibility to ensure that his/her work is not subject to libel, defamation of character or in violation of copyright laws.
- 11. Please note that your work may not be displayed to your satisfaction owing to the large number of works and limited space. Artsource reserves the right not to hang all works.
- 12. All artworks must be submitted with the packing slip securely attached with the following details: artist's name, year, title, medium, price, including 25% commission + GST if applicable

SALES & FEES

- **13.** Entry (either online or by hard copy) must be accompanied by the Administration Fee of \$30.00 (incl. GST). This fee is not refundable.
- **14.** All works must be for sale. Sale price must include a 25% commission + GST if applicable. The sale price indicated in the entry form shall apply and shall remain fixed for the duration of the exhibition.
- **15.** If artwork is sold, 25% commission will be deducted from the sale price by Artsource, with payment to the artist made by end of February 2019.

REPRODUCTION, PROMOTION & COPYRIGHT

16. The artist agrees to allow any work to be reproduced in part or whole by print or electronic media only for promotion, review and educational purposes and future promotion of the exhibition. The artist remains the owner of the copyright of the artwork.

INSURANCE

17. Works will NOT be covered by Artsource insurance. Artsource will take all reasonable care, however; they can accept no responsibility for damage, loss, fire, theft or vandalism. Artists are advised to insure their work against loss, theft or damage, and are responsible for their own transit insurance.

RETURN OF WORKS

18. Works are to be collected at the specified times. Should you be unable to collect work on this date, prior arrangements must be made to collect the work. Artsource reserves the right to sell or otherwise dispose of works not collected by Friday 11 January 2019 where arrangements have not been made for collection or return freight. Works will be returned in the original packing and it is the responsibility of the artist to ensure their packing material is sufficient for return transportation.
